### STAFF REPORT

#### <u>SUBJECT</u>

A motion to confirm the Executive's appointment of Patricia Davis as the Director of the Road Services Division of the King County Department of Local Services.

#### <u>SUMMARY</u>

Proposed Motion 2020-0415 would confirm the appointment of Patricia Davis as the Director of the Road Services Division of the Department of Local Services (DLS). The King County Code provides for the Council to confirm or reject appointments of key subordinate positions including the director of the road services division.<sup>1</sup>

#### BACKGROUND

The DLS Road Services Division is the county agency primarily responsible for the King County Unincorporated Area Roads, a regional transportation system consisting of 1,500 miles of roads, 182 bridges and which sees an average of more than one million trips per day. The division has a biennial budget of over \$250 million and employs nearly 400 staff members.

K.C.C. 2.16.055.H. describes the responsibilities of the Road Services Division:

H. The road services division is responsible for designing, constructing, maintaining and operating a comprehensive system of roadways and other transportation facilities and services to support a variety of transportation modes for the safe and efficient movement of people and goods and delivery of services. The duties of the division shall include the following:

1. Designing, constructing and maintaining county roads, bridges and associated drainage facilities;

2. Designing, installing and maintaining county traffic signs, markings and signals;

3. Designing, installing and maintaining bicycle and pedestrian facilities;

4. Managing intergovernmental contracts or agreements for services related to road maintenance and construction and to other transportation programs supporting the transportation plan;

5. Inspecting utilities during construction and upon completion for compliance with standards and specifications; assuring that public facilities disturbed due to construction are restored;

6. Performing detailed project development of roads capital improvement projects that are consistent with the transportation element of the county's Comprehensive Plan, and coordinating such programming with other county departments and divisions assigned responsibilities for Comprehensive Plan implementation;

7. Incorporating into the roads capital improvement program those projects identified in the transportation needs report, community plans, related functional plans and elsewhere consistent with the county's Comprehensive Plan;

8. Preparing, maintaining and administering the county road standards;

9. Preparing and administering multiyear roads maintenance and capital construction plans and periodic updates;

10. Administering the transportation concurrency and mitigation payment programs; and

11.a. Performing the duties of the office of the county road engineer, which is hereby established as an administrative office of the road services division. The office of the county road engineer shall be an office of record, supervised by the county road engineer hired in accordance with RCW 36.80.010 and reporting to the manager of the road services division. The office of the county road engineer shall be located within the corporate limits of the county seat.

b. The county road engineer shall carry out all duties assigned to the county road engineer as prescribed by state statute, except as modified by the county executive as authorized in subsection H.11.c. of this section.

c. The county executive may assign professional engineering duties of the county road engineer to someone other than the county road engineer, except as otherwise assigned by the King County Code, and only if the individual assigned those duties shall be qualified as required under RCW 36.80.020. The executive shall provide to the county council and the Washington state County Road Administration Board, in writing, those specific professional engineering duties not assigned to the county road engineer, the name and position of each person responsible for carrying out those assigned duties, the specific reporting and working relationships with the county road engineer and the duration for which those duties have been assigned.

#### **Experience of Appointee:**

Ms. Davis has been with King County for over thirteen years. Most recently she served as the Deputy Director of the Rail Operations Division of the Metro Transit Department. Prior to that she was a Budget Supervisor in the Office of Performance, Strategy and Budget Before coming to the County Ms. Davis served five years in the United States Navy's Surface Warfare Office and, deployed abroad, as an engineering officer on nuclear powered vessels. She has a bachelor's degree from Duke University and a Master's in Public Administration from the University of Washington.

### **ANALYSIS**

The King County Code requires the Council to confirm or reject appointments of key subordinate positions including the director of the road services division. Approval of the Proposed Motion would fulfill the code requirement.

# Tricia Davis named Director of King County Local Services Road Services Division

#### SUMMARY

Local Services Director John Taylor this week announced the appointment of Davis – who's currently Deputy Director of King County Metro's Rail Operations Division.

She will begin working with Road Services in November, and her appointment will be effective once the King County Council confirms it later this year.

#### STORY

Davis is a veteran who served five years with the United States Navy's Surface Warfare Office, and deployed abroad as an engineering officer on nuclear powered vessels. She holds a Bachelor of Science Degree in Biomedical Engineering from Duke University and a Master's Degree in Public Administration from the University of Washington.

Davis has been with the county over 13 years, serving as the Deputy Director of the Rail Operations Division since June 2019. Before that, she spent nearly 11 years as that division's budget supervisor, and before that she was a budget analyst.

Before joining the county, Davis was a research analyst for the Center on Reinventing Public Education. She also worked for Capital One Financial Services as a senior operations analyst.

She will now lead a division that maintains 1,500 miles of roadway and 182 bridges in unincorporated King County. Road Services has more than 400 employees and six divisions.

Davis will replace Road Services Division Director Rick Brater, who is retiring at the end of 2020 after nearly 20 years with King County.

Finding a new Road Services director involved a months-long process that was complicated by the COVID-19 pandemic. Local Services held online panel interviews

with candidates and representatives from the Road Services Division, the Department of Natural Resources and Parks, and King County councilmembers' offices. Local Services' Equity and Social Justice Advisory Committee played a key role in the decision

"Tricia takes the helm of one of the most diverse divisions and management teams in the county, which under the leadership of Rick Brater developed a strategic plan that preserved a road system impacted by significant funding shortfalls," Taylor said. "Tricia is a proven leader and has a well-earned reputation of leading with King County values and a commitment to racial justice. She is a problem solver, an innovative and strategic thinker, and is the perfect fit to help the Road Services Division confront its historic funding challenges and move into a new era of financial stability."

"I am excited to join the hardworking team at Road Services and the Department of Local Services to continue to deliver excellent service to the residents of unincorporated King County," Davis said. "I also look forward to taking on the challenge of securing sustainable funding for our vital road and bridge network so that we can continue in making King County a *welcoming community where every person can thrive."*

I am writing to support the appointment of Tricia Davis to be the Director of the Road Services Division in the Department of Local Services. It has been my pleasure to have worked with Tricia throughout my over ten years with the County and I believe she will be an outstanding Roads Director.

I first met Tricia many years ago when she took a course in public finance that I taught at the University of Washington. She was the first County employee I met when I came for my interview with Executive Constantine and Deputy Executive Jarrett in February 2010. She recognized me from the UW class and encouraged me to take a job I had not yet been offered!

When I started as the PSB Director, Tricia was one of the budget managers and was responsible for the physical environment budgets, including the Road Services Division. Tricia was instrumental in helping me understand these budgets and she and her team did great work in managing these budgets in periods of both growth and contraction. 

# SUPPLEMENTAL INFORMATION: ABOUT THE DIVISION

Unincorporated King County is home to roughly a quarter million people. Collectively, these communities would be the second-largest city in the state. Millions more use the roads to access jobs and recreational activities in urban and rural King County. The Roads Services Division is committed to ensuring the county's road system is safe and efficient for all uses and modes of travel.

The division is faced with a long-term structural funding problem, yet is responsible for 1,500 miles of roads and 182 bridges, 5.7 million feet of drainage ditches, over 44,000 traffic control signs, 78 traffic signals, and 50 traffic cameras in unincorporated King County.

The Division is part of the Department of Local Services, which also includes a Director's Office and the Permitting Division. Together, this department provides a single executive point of accountability for delivery of local services to all of the unincorporated areas. The Roads Services Division works most closely with the US Department of Transportation, the Washington State Department of Transportation, King County's Department of Natural Resources, Metro Transit, and the Permitting Division to meet its objectives.
