ORDINANCE 19200

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing remotely to compily with the Washington State Governor's Declaration 20-28 (or as mended) regarding the Open Public Meetings Act on Tuesday, November 17, 2020, beginning at 1:00 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2020-2322 (Ordinance 19200), adopting the restructure of the Utilities Technical Review Committee and School Technical Review Committee.

Ordinance 19200 aligns staffing of the committees with the appropriate County agencies, most substantially to align with the local services and regulatory functions of the Department of Local Services in accordance with a reallocation of expenditure authority for the staffing and membership of the Utilities Technical Review Committee and School Technical Review Committee as included in the 2021-2022 King County Biennial Budget. Ordinance 19200 effectuates these changes in the King County Code.
