

# MIDD's Role in King County's Behavioral Health System

## MIDD Policy Goals

- Divert from costly interventions such as jail, emergency departments, and hospitals
- Reduce the number, length, and frequency of BH crisis events.
- Improve health and wellness of individuals
- Increase culturally appropriate and trauma-informed BH services
- Explicit linkage with, and furthering the work of, King County and community initiatives





Adult jail bookings




Crisis event duration




Emergency department admissions





## Crisis Diversion


#### High Utilizer Care Teams

Long-term outcome results on ED admissions were available for 150 participants. Among those, admissions decreased by 75 percent



# Adult Crisis Diversion Center, Respite Beds and Mobile Behavioral Health Crisis Team

Long-term outcome results on crisis events were available for 1,575 participants. Among those, crisis events decreased by 69 percent

Recovery and Reentry

Total Investments in 2019

#### Peer Bridger Programs

76% of participants were linked to treatment within a year



#### Recovery Café

MIDD funding supported expansion of Recovery Café to it's SODO which opened in early 2020

#### Rapid Rehousing Oxford House Model

68% of the 139 participants who left the program in 2019 stayed sober and completed the program

## System Improvement (SI) •

Strengthens access to the behavioral health system and equip providers to deliver on outcomes more effectively



## System Improvement

#### Workforce Development

Workforce Development trained 1,071 participants. 92 percent of participants across the trainings held said they would recommend the training they attended to others



#### Quality Coordinated Outpatient Care

Behavioral Health Services in Rural King County Launched December 2019

Community Driven Behavioral Health Services Launched January 2020

# Therapeutic Courts (TX)

Supports people experiencing behavioral health conditions who are involved with the criminal legal system by helping them to achieve stability and avoid further legal system involvement

#### Adult Drug Court

Participants reported reduced/stable low or no substance use



#### Family Treatment Court

Long-term outcome results were available for 54 participants. Among those, adult jail bookings decreased by 71 percent.
