1	AN ORDINANCE approving the Sallal Water Association
2	2006, Revised July 2009, Water System Plan.
3	STATEMENT OF FACTS:
4	1. King County adopted K.C.C. chapter 13.24, which requires approval of
5	comprehensive plans for water and sewer utilities that distribute or obtain
6	water in unincorporated King County as a prerequisite for operating in
7	unincorporated King County, receiving approval for annexation proposals,
8	being granted right-of-way franchises and being given approval for right-
9	of-way construction permits. K.C.C. 13.24.060 prescribes the
10	requirements for approval of such plans, including consistency with state
11	and local planning requirements.
12	2. RCW 70.116.050 requires that water system plans developed by
13	purveyors within the boundaries of a critical water supply service area be
14	reviewed by local governments to ensure that the plan is not inconsistent
15	with the land use plans, shoreline master programs and developmental
16	policies of those local governments.
17	3. The Sallal Water Association's last water system plan was prepared in
18	2001. Both Washington state Department of Health and King County
19	regulations require water system plans to be updated every six years.

20	4. The Sallal Water Association ("the association") is located in King
21	County and has adopted a 2006, revised 2009, water system plan ("the
22	plan").
23	5. King County has adopted a comprehensive plan that includes water
24	supply policies in its provisions for facilities and services (policies F-213
25	through F-245) that call for comprehensive plans to be consistent with
26	other adopted plans, support for regional water supply planning, pursuit of
27	reclaimed water and water conservation, and protection of water
28	resources.
29	6. K.C.C. chapter 13.24 requires review of water system plans by the
30	utilities technical review committee ("UTRC"), and that a
31	recommendation be made to the King County executive and council on the
32	plan and the requirements under K.C.C. chapter 13.24 and consistency
33	with the King County Comprehensive Plan. The UTRC has reviewed the
34	planning data and association operations and hereby finds:
35	a. The plan uses the population and employment forecasts developed by
36	the Puget Sound Regional Council for the association's service area with a
37	customized forecast appropriately used;
38	b. The plan uses King County land use classifications;
39	c. The capital facility plan is adequate to meet anticipated facility and
40	service needs;
41	d. The plan is consistent with applicable state water quality laws,
42	including the evaluation of reclaimed water use; and

43	e. The plan is consistent with other pertinent county adopted plans and
44	policies.
45	7. The Washington state Department of Health has not yet approved the
46	association's plan pending plan approval by King County.
47	8. The association completed a state Environmental Policy Act checklist
48	and King County, as lead agency, issued a determination of
49	nonsignificance for the issuance of the plan on August 5, 2009.
50	9. The association's operations and facilities meet multiple existing
51	statutory, administrative, and planning standards. As the association's
52	operations, facilities, and planning meet the requirements of the King
53	County Code and are consistent with the King County Comprehensive
54	Plan, the UTRC recommends approval of the plan.
55	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
56	SECTION 1. The Sallal Water Association 2006, Revised July 2009, Water

- 57 System Plan, Attachment A to this ordinance, is hereby approved as a comprehensive
- water system plan.


