## Ordinance 16772

	Proposed No. 2009-0597.3 Sponsors Dunn
1	AN ORDINANCE approving, subject to conditions, the
2	extension of Franchise 13637 for two additional years.
3	STATEMENT OF FACTS:
4	1. King County is granted authority under federal and county law and the
5	terms of the existing cable television franchise to grant an extension to the
6	term of Franchise via King County Ordinance 13637 held by Summit
7	Cablevision L.P. ("the franchisee") and Millennium Digital Media
8	Systems, L.L.C., the sole general partner and the owner of all partnership
9	interests in Summit Cablevision L.P., as guarantor.
10	2. The franchisee provides cable television service in unincorporated
11	King County under cable television franchise via King County Ordinance
12	13637 ("the franchise agreement").
13	3. The franchise agreement expired October 11, 2009.
14	4. K.C.C. 6.27A.030.A. provides for franchise terms of no more than
15	fifteen years. The franchisee was granted a ten-year term pursuant to
16	Ordinance 13637.
17	5. On January 2, 2009, the franchisee and guarantor commenced cases
18	under Chapter 11 of Title 11 of the United States Code.

19	6. On June 30, 2009, the county filed a proof of claim with the United
20	States Bankruptcy Court for the District of Delaware.
21	7. The bankruptcy was not concluded before October 11, 2009.
22	8. During the past two years, the county conducted an audit to determine
23	if all franchise fees owed under the franchise agreement were paid by the
24	franchisee. The auditor determined that the franchisee owes the county
25	money for unpaid franchise fees.
26	9. In May 2006, February 2007 and October 2008, the county performed
27	technical audits of the franchisee's cable system to determine if the cable
28	system met the operational and technical requirements identified in the
29	franchise agreement. The county's consultant determined that the
30	franchisee was not in compliance with the technical requirements of the
31	franchise agreement.
32	10. The franchisee is not in compliance with technical matters related to
33	the operation of the cable system and the subscribers served by the
34	franchisee. Further, as a result of the unpaid franchise fees and the
35	pending bankruptcy, the franchisee is not in financial compliance with the
36	franchise agreement.
37	11. Due to the franchisee's noncompliance with the technical and
38	financial requirements to provide cable services, a renewal of the existing
39	franchise in accordance with K.C.C. 6.27A.060 is not in the public
40	interest.

41	12. In order to provide the franchisee with time to meet the technical and
42	financial requirements of holding a franchise, the county is authorizing,
43	subject to conditions, a two-year extension of the franchise agreement to
44	October 11, 2011.
45	13. The county has received public comment and public testimony
46	regarding the proposed extension of two additional years.
47	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
48	SECTION 1. A. King County hereby grants an extension to the term of the
49	franchise agreement for one additional year, subject to the following conditions as set
50	forth and agreed to by the county and Summit Cablevision L.P., the franchisee, and
51	Millennium Digital Media Systems, L.L.C., the sole general partner and the owner of all
52	partnership interests in Summit Cablevision L.P. as guarantor.
53	B. The franchisee shall confirm in writing that approval by the county of the two-
54	year extension of the franchise terms shall not constitute a waiver or release of any rights
55	of the county under the franchise agreement, prior transfer ordinances or applicable law,
56	before or after the effective date of the one-year extension of the franchise terms.
57	C. Millennium Digital Media Systems, L.L.C. shall confirm in writing that the
58	performance guarantees on behalf of Summit Cablevision L.P. shall remain in full force
59	and effect before and after the effective date of this ordinance and through the term of the
60	extension.
61	D. Franchisee and guarantor shall submit written confirmation that the
62	Bankruptcy Court has approved the extension and the guarantee.

63	E. Upon satisfaction of all the franchise extension requirements described in this
64	ordinance, the executive is authorized to enter into a franchise amendment to extend the
65	franchise agreement for two additional years, to October 11, 2011.
66	SECTION 2. Where this ordinance requires submittal of written confirmations by
67	the franchisee, the confirmation shall be filed with the clerk of the council, and a copy
68	shall be filed with the office of cable communications. If the conditions for the extension

- 70 of two additional years are not satisfied, the extension shall be deemed denied and
- 71 Franchise 13637 terminates October 11, 2009.

### FRANCHISE AGREEMENT NO. 13637 Revised 02-16-2010

Franchise Agreement No. 13637 currently in effect between King County and Summit Cablevision L.P., Franchisee, and Millennium Digital Media Systems, L.L.C., the sole general partner and the owner of all partnership interests in Summit Cablevision L.P., as Guarantor, is hereby amended to extend the franchise term for two years to October 11, 2011.
