	Dembowski	Pg. 10, Beg. of line 204	Increases from at least \$235M to \$240M the total amount allocated for the YFHPI, child care subsidy program, child care workforce demonstration project and technical assistance and capacity building.  Directs \$1 million of this amount annually for capacity building grants to assist with development of infrastructure in geographic locations lacking services or service infrastructure. The grant program would be described in the implementation plan and must include the development of new organizations and expansion of organizations.
