15 compliance. If the best starts for kids fund, or its successor, contains any uncommitted
16 levy proceeds, such levy proceeds may be allocated for capital investments for buildings
17 and facilities that serve children and youth, including, but not limited to, recreation and
18 community facilities, housing, child care facilities and early learning facilities. If any

19 such levy proceeds are allocated for capital investments, priority shall be given to
20 supporting repairs or renovations of existing buildings and facilities. The executive shall
21 propose a process for allocating any uncommitted proceeds in the implementation plan
22 required by section 7 of this ordinance."

27 **EFFECT prepared by *Wendy Soo Hoo*: Adds a statement of fact stating that**
28 **buildings and facilities are needed to provide programs and, currently, funding to**
29 **provide and maintain some buildings and facilities is limited. Uncommitted**
30 **proceeds because of variations in expenditures, collections or underperformance**
31 **may be allocated for capital investments including, recreation and community**
32 **facilities, housing, child care facilities and early learning facilities. Requires that**
33 **priority for any capital investments be given to repairs/renovations of existing**
34 **facilities. Requires the executive to propose a process for allocating uncommitted**
35 **proceeds in the implementation plan.**

15 council by ordinance, shall be provided to such junior taxing district."

22 other reduction in the total amounts allocated for the purposes in subsections C. and D. of
23 this section. This capital grants program shall be described in the implementation plan
24 required in section 7 of this ordinance. Additionally, the executive shall propose in the
25 implementation plan required in section 7 of this ordinance a process for determining
26 annually if a reduction to the amount of levy proceeds allocated for the purposes of this
27 subsection is necessary and the amount of any such reduction."

29 **EFFECT prepared by *Tillery Williams*:**

30 **Creates a capital grants program that provides grants (no less than \$50,000,000 over**
31 **the course of the levy) for facility/building repairs and expansion, and to support the**
32 **construction of new buildings or facilities that will serve children and youth and**
33 **specifies that the grant program be described in the implementation plan required**
34 **in section 7 of this ordinance. Also requires that this allocation be reduced first if**
35 **revenues are less than OEFA projected \$872 million over the life of the levy. The**
36 **process for determining annually whether a reduction is necessary would be**
37 **required to be proposed in the implementation plan.**
