Dear Councilmember Balducci:

This letter transmits a proposed supplemental budget ordinance for the Harborview Medical Center (HMC) bond program. If approved, this funding would enable King County to procure project management and land use consultants for the Harborview bond program. The funding would also enable the hiring of additional staff to implement the Harborview bond program, supplementing initial program funding allocated in the 2021-2022 adopted budget.

On November 3, 2020 King County voters overwhelmingly approved a ballot measure that authorizing the issuance of bonds to support extensive capital improvements to the Harborview Medical Center campus. The adopted 2021-2022 includes initial funding for HMC capital program staffing budgeted in the Facilities Management Internal Services fund.

The capital budget component of this proposed budget will be budgeted in a new capital fund entitled *HMC Capital Program 2020 Prop 1*. A proposed ordinance establishing this capital fund is being transmitted to the King County Council for consideration separately.

The proposed supplemental budget will be allocated to six of the major facility projects as follows:

- 1. Patient tower facility construction;
- 2. Behavioral health facility provision;
- 3. Harborview Hall restoration and increased respite bed capacity;
- 4. Center Tower seismic retrofit;
- 5. Miscellaneous building changes including Involuntary Treatment Court expansion and relocation of Department of Public Health services located on the Harborview Campus; and
- 6. Infrastructure improvements to the HMC campus.

As specified by King County Code, a capital project with a proposed budget greater than \$10 million is subject to a standard two-step process to determine whether it will be subject to mandatory phased appropriation (MPA) requirements associated with project risk. To expedite the MPA determination process, I am exercising the authority granted to the Executive in KCC 4A.130.020.G to immediately designate five of the six projects as MPA projects. The Miscellaneous Building project will follow the standard two-step process used to determine whether a project is an MPA project.

The ordinance supports the King County Strategic Plan goal to exercise sound financial management and build King County's long-term fiscal strength.
