Re: Proposed Ordinance 2010-0258 - authorizing King County to condemn the road right-of-way through Tax Parcel 1124079028

This is to advise you that at the April 27, 2010 meeting of the Environment and Transportation Committee of the Metropolitan King County Council. Proposed Ordinance 2010-0258 will be up for discussion and possible action. Proposed Ordinance 2010-0258 authorizes the condemnation of fee title to an existing road right of way through Tax Parcel No. 1124079028, property owned by Rutherford Slough LLC, for which you serve as the registered agent.
