## **REQUEST DESCRIPTION:**

Add appropriation for the Jail Management System Project (1129763), which is deploying a comprehensive and integrated technology system to help the Department of Adult and Juvenile Detention (DAJD) to achieve more effective and efficient jail operations. In addition, dis-appropriate unused appropriation balances from completed projects and add budget authority for the KCIT Capital Project DFLT administrative project (1111936) to transfer out residual funds back to the original funding sources.

### Does this legislation require a budget supplemental?

Notes and Assumptions:

-- DAJD Jail Management System (1129763): The requested appropriation of \$2.67 million will fund the cost increase of the continued effort of replacing the County's 40-year-old legacy system with a new, integrated Jail Management System. An additional budget authority is needed because of the total project cost increase due to a change in the go-live date, and also various unanticipated challenges the project has encountered.

--- KCIT Capital Project DFLT (1111936): The \$996K includes residual funds from the following projects: \$2,337 from DES RALS Records Mgmt Sys Upgde (1129348), \$321,642 from KCSO KCIT IRIS/TESS REPL (1111808), \$34,924 from DES FBOD CW Elec Pmt Imp Sppt (1124170), \$31,666 from DES RM Risk Master Replc (1126546), and \$605,344 from DOT Fleet Vehicle Loc for NRV (1129703).
