5	SECTION 1. There is hereby added to K.C.C. chapter 4A.200 a new section to
6	read as follows:
7	A. There is hereby created the Harborview Medical Center capital program 2020
8	Proposition 1 capital project fund.
9	B. The fund shall be a first tier fund. It is a capital project fund.
10	C. The director of the department of executive services shall be the manager of
11	the fund.
12	D. Revenue approved by the voters of King County at the November 4, 2020,
13	general election as described in Ordinance 19117 shall be deposited in the fund.
14	E. The fund shall be used to account for the capital costs of the Harborview
15	Medical Center capital project as described in Ordinance 19117.

F. Any subfund of the fund created to hold and manage bond proceeds shall be
treated as a first tier fund.

### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
