2021 AMENDMENT TO CONTRACT FOR LOWER GREEN RIVER CORRIDOR PLAN AND PEIS PROJECT MANAGER SERVICES KING COUNTY FLOOD CONTROL ZONE DISTRICT

THIS AMENDMENT amends Sections 1, 2 and 3 of the Contract for Lower Green River Corridor Plan and PEIS Project Manager Services ("Contract") between the King County Flood Control Zone District, King County, Washington, a municipal corporation of the State of Washington ("District") and Lund Consulting Inc. ("Consultant"), as follows:

- A. <u>Amendment of Section 1</u>. Effective September 1, 2021, Section 1 of the Contract is amended as follows:
 - 1. <u>Scope of Services to be Performed by Consultant</u>. The Consultant shall perform the services described in Exhibit "A" to the 2021 Amendment. In performing the services, the Consultant shall comply with all federal, state and local laws and regulations applicable to the services. The Consultant shall perform the services diligently and completely and in accordance with professional standards of conduct and performance.
- B. <u>Amendment of Section 2</u>. Effective September 1, 2021 Section 2 of the Contract is amended as follows:
 - 2. <u>Compensation and Method of Payment</u>. The Consultant shall request payment for work performed using the billing invoice form at Exhibit "B." The District shall pay the Consultant according to the rates set forth in Exhibit "A" to the 2021 Amendment.

The Consultant shall complete and return to the District Exhibit "C, Tax Identification Number," prior to or along with the first billing invoice.

- C. <u>Amendment of Section 3.</u> Section 3 of the Contract is amended as follows:
- 3. <u>Duration of Contract</u>. This Contract shall be in force and effect for a period commencing on September 1, 2021 and ending August 31, 2022, unless sooner terminated or extended under the provisions of this Contract. Time is of the essence of this Contract in each and all of its provisions in which performance is required.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
