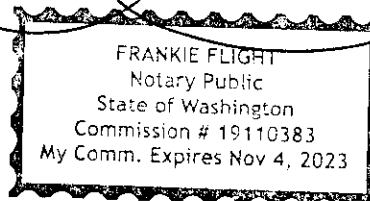

NOTICE OF RULEMAKING -
BOH 21-02**

Pursuant to its authority under RCW 70.05.060, the King County Board of Health hereby gives notice of proposed rulemaking. A RULE AND REGULATION relating to secure medicine return regulations; suspending the operation and effect of R&R 14-02, Section 2, and BOH 2.15F.010, R&R 14-02, Section 3, as amended, and BOH 2.15F.020, R&R 14-02, Section 4, as amended, and BOH 2.15F.030, R&R 14-02, Section 5, as amended, and BOH 2.15F.040 and R&R 14-02, Section 6, as amended, and BOH 2.15F.050, R&R 13-03, Section 3, and BOH 11.50.010, R&R 13-03, Section 4, and BOH 11.50.020, R&R 13-03, Section 5, and BOH 11.50.030, R&R 13-03, Section 6, and BOH 11.50.040, R&R 13-03, Section 7, and BOH 11.50.050, R&R 13-03, Section 8, and BOH 11.50.060, R&R 13-03, Section 9, and BOH 11.50.070, R&R 13-03, Section 10, and BOH 11.50.080, R&R 13-03, Section 11, and BOH 11.50.090, R&R 13-03, Section 12, and BOH 11.50.100, R&R 13-03, Section 13, and BOH 11.50.110, R&R 13-03, Section 14, and BOH 11.50.120, R&R 13-03, Section 15, and BOH 11.50.130, R&R 13-03, Section 16, and BOH 11.50.140, R&R 13-03, Section 17, and BOH 11.50.150 and R&R 13-03, Section 18, and BOH 11.50.160; adding a new section to BOH chapter 2.15F and adding a new section to BOH chapter 11.50, enacted pursuant to RCW 69.48.160 and RCW 70.05.060, including the latest amendments or revisions thereto. The proposed amendments would suspend the King County secure medicine return program so long as the state Department of Health drug take-back program remains operational.

A public hearing on the proposed rule at which the public may state their views orally or in writing will be held during the regular meeting of the King County Board of Health, November 18th, 2021 at 1:00 p.m. The public hearing is planned to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act. Information on this public hearing, including how to submit public testimony and attend the meeting, will be posted on the Council's website ahead of the hearing. Written comments mailed or delivered to this address must be received by 5 p.m. on the day preceding the Board of Health meeting.
