SUMMARY

Proposed Motion 2010-0397 (pp. 3-7 of these materials) would recognize the King County Director of Elections, Sherril Huff, for achieving the status of Certified Election Administrator and would request periodic reports regarding the director's maintenance of certification.

BACKGROUND

In November of 2008 the voters of King County approved charter amendments making the position of King County Director of Elections an elective office and allowing the Council to establish by ordinance additional qualifications for the office (besides the charter requirement of being at least 21 years old, a U.S. citizen, and a resident and registered voter of King County).

Because the complexity of modern election systems makes it necessary for a director of elections to possess certain technical and administrative qualifications and expertise in order to perform effectively in that role, the Council by Ordinance 16302 (pp. 9-13 of these materials) established additional qualifications for the office of Director of Elections. Those qualifications included a requirement that "[n]o later than thirty months after having been elected or appointed to the office of elections director, the director shall have earned the certification of elections administrator from the Washington state Office of the Secretary of State, and shall meet all continuing education requirements of the Secretary of State."

As demonstrated by the letter from the Washington Secretary of State that is Attachment A to Proposed Motion 2010-0397 (p. 7 of these materials), King County Director of Elections Sherril Huff has obtained certification as a Certified Election Administrator, as required by Ordinance 16302, and her certification will extend through the end of this year.

In order to maintain certification by the Secretary of State, election administrators are required to obtain 18 hours of continuing education each year, as provided in WAC 434-260-300 (p. 15 of these materials).

PROPOSED MOTION 2010-0397

Proposed Motion 2010-0397 would:

- 1. Recognize and congratulate the Director of Elections for obtaining certification as a Certified Election Administrator;
- 2. Request that the Director of Elections provide a written report to the Council no later than September 1 of each year, beginning this year, detailing the hours of continuing education that the director has obtained, or plans to obtain, in order to maintain certification through the following calendar year; and
- 3. Request that the Director of Elections inform the Council promptly in writing of any extension or termination of the director's certification as a Certified Election Administrator.

5	WHEREAS, the voters of King County on November 4, 2008, approved a charter
6	amendment making the position of county director of elections an elective office, and
7	WHEREAS, the complexity of modern election systems makes it necessary for
8	the county director of elections to possess certain technical and administrative
9	qualifications and expertise in order to perform effectively in that role, and
10	WHEREAS, the voters of King County on November 4, 2008, approved a charter
11	amendment allowing the county council to establish by ordinance additional
12	qualifications for the office of director of elections, besides the charter requirement of
13	being at least twenty-one years old, a citizen of the United States and a resident and
14	registered voter of King County, and
15	WHEREAS, the county council by Ordinance 16302 established additional
16	qualifications for the office of director of elections, including a requirement that "[n]o
17	later than thirty months after having been elected or appointed to the office of elections
18	director, the director shall have earned the certification of elections administrator from

19	the Washington state Office of the Secretary of State, and shall meet all continuing
20	education requirements of the Secretary of State," and
21	WHEREAS, as demonstrated by the letter from the Washington Secretary of State
22	that is Attachment A to this motion, King County director of elections Sherril Huff has
23	obtained certification as a Certified Election Administrator, as required by Ordinance
24	16302, and
25	WHEREAS, once certified, election administrators are required, in order to
26	maintain their certification, to obtain eighteen hours of continuing education each year, as
27	provided in WAC 434-260-300;
28	NOW, THEREFORE, BE IT MOVED by the Council of King County:
29	A. The council recognizes and congratulates King County director of elections
30	Sherril Huff for obtaining certification as a Certified Election Administrator, effective
31	from June 1, 2010, through December 31, 2010.
32	B. The council requests that the director of elections provide a written report to
33	the council no later than September 1 of each year, beginning in 2010, detailing the hours
34	of continuing education that the director has obtained, or plans to obtain, in order to
35	maintain certification through the following calendar year.
36	C. The council requests that the director of elections inform the council promptly
37	in writing of any extension or termination of the director's certification as a Certified
38	Election Administrator.
39	D. The reports referred to in subsections B. and C. of this motion shall be filed
40	electronically with the clerk of the council, who shall forward electronic copies to each

	Proposed No. 2008-0615.2 Sponsors Patterson
1	AN ORDINANCE establishing qualifications for the
2	elected office of King County director of elections; and
3	adding a new chapter to K.C.C. Title 2.
4	STATEMENT OF FACTS:
5	1. Initiative 25 placed a charter amendment on the November 4, 2008,
6	ballot asking the electorate if it wants to amend the King County Charter
7	to establish the office of an elected director of elections.
8	2. Ordinance 16206 placed a charter amendment on the November 4,
9	2008, ballot asking the electorate if it wants the county council to have the
10	authority to establish qualifications for office for a variety of county
11	officials including an elected director of elections.
12	3. Conducting accurate, fair and transparent elections is one of the most
13	important functions of King County government.
14	4. King County has made significant improvements in the conduct of
15	elections since the general election of 2004.
16	5. It is critical to continue to make improvements to elections operations
17	both for reasons of governance as well as maintaining public confidence.
18	6. Conducting elections is very challenging and requires strong technical
19	skills as well as top level management skills and integrity.

20	7. It is in the public interest that minimum qualifications for an elected
21	director of elections be established in order to help ensure that the director
22	of elections has the requisite skills and character to properly manage the
23	function.
24	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
25	SECTION 1. Sections 2 through 6 of this ordinance should constitute a new
26	chapter in K.C.C. Title 2.
27	NEW SECTION. SECTION 2. In addition to qualifications in the King County
28	Charter, the qualifications for the office of King County director of elections are:
29	A. The person shall not hold an office in a political party while serving as the
30	director of elections;
31	B. For one year immediately before filing to run for, being appointed to or
32	holding the office, the person shall not be or have been employed by, or performed
33	compensated services for or hold a financial interest in, a nongovernmental entity that
34	designs, manufactures or sells elections tabulation or voter registration equipment or
35	software. For the purposes of this subsection, "financial interest" means an interest that
36	exceeds one-tenth of one percent of the outstanding securities of the nongovernmental
37	entity; or if the interest is in an unincorporated business concern, exceeds one percent of
38	the net worth of such concern; or the financial interest in the nongovernmental entity
39	exceeds five percent of the net worth of the person and the person's immediate family, as
40	defined in K.C.C. 3.04.017.H. Nothing in this subsection is intended to prevent a person
41	from holding the office who has been employed by, performed services for or holds a
42	financial interest in a nongovernmental entity that sells, designs or manufactures

43 equipment or software that has broad commercial application beyond the field of

44 elections tabulation or voter registration; and

C. No later than thirty months after having been elected or appointed to the office
of elections director, the director shall have earned the certification of elections
administrator from the Washington state Office of the Secretary of State, and shall meet

all continuing education requirements of the Secretary of State.

MEW SECTION. SECTION 3. This chapter does not prevent an elected official
from holding another public office while filing and running as a candidate for King
County director of elections.

<u>NEW SECTION. SECTION 4.</u> This chapter does not prevent the director of
 elections from filing and running for another public office while still serving as the
 director of elections.

NEW SECTION. SECTION 5. For the initial election of a director of elections, 55 the manager of the elections division shall establish a candidate filing form for the office 56 of director of elections whereby candidates filing for office swear or affirm that they 57 comply with all the qualifications for the office as established by state law, the King 58 59 County Charter and the King County Code. The filing form shall contain the specific requirements of this chapter. Following the initial election, the elected director of 60 elections shall establish the filing form in conformance with applicable King County 61 62 Charter and King County Code provisions.

NEW SECTION. SECTION 6. The director of elections shall continue to fulfill
 the qualifications established in this chapter for the term of office. The failure to
 continue to fulfill any qualification of this chapter causes a vacancy in the office, which

- shall be filled in accordance with Section 680.10 of the King County Charter.
- 67 <u>SECTION 7.</u> This ordinance takes effect if the canvassing board certifies voter
- approval in November 2008 of proposed Charter Amendment 4, amending Section 630 of

- 69 the King County Charter, pertaining to the establishment by the council of additional
- 70 qualifications for separately elected officials who head executive departments.

WAC 434-260-300 Maintaining certification as an election administrator.

After attaining initial certification the election administrator is responsible for maintaining his or her certification. Maintenance of certification shall consist of:

(1) Continuous service as an election administrator during the year for which maintenance is required;

(2) Participation in an annual minimum of eighteen hours of continuing education, at least six hours of which shall be on election-specific training. This training may be received at any election oriented workshop or conference sponsored by any of the organizations listed in WAC 434-260-220. In addition to receiving credit for participation in election workshops or conferences, election administrators may also receive a maximum of two hours for visiting other county election departments for training purposes and for any other training approved by the elections administration and certification board. A maximum of six hours, of the eighteen required, may be derived from a surplus of hours earned in the previous year.
