1 A MOTION requesting the executive review home 2 occupation and home industry regulations and update as 3 necessary to account for workforce and business operation 4 changes related to the COVID-19 pandemic; and requiring 5 a report. 6 WHEREAS, the COVID-19 pandemic has fundamentally changed how 7 businesses in King County operate, and 8 WHEREAS, over one-third of households nationwide reported working from 9 home more frequently than before the COVID-19 pandemic, and 10 WHEREAS, the existing home occupation regulations do not contemplate 11 changes in the work environment including remote work, changing consumer preferences 12 and technological shifts; and 13 WHEREAS, many businesses continue to have work from home policies, citing 14 changes in employee preferences and the resurgence of positive COVID-19 cases due to 15 the Delta variant; 16 NOW, THEREFORE, BE IT MOVED by the Council of King County: 17 A. The council requests that the executive conduct a review of the county's home 18 occupation and home industry regulations in K.C.C. Chapter 21A.30 and update the code 19 as necessary to account for workforce and business operation changes related to the 20 COVID-19 pandemic.

21	B. The study should include the following:		
22	1. An analysis of uses that are permitted and prohibited under a home occupation		
23	and home industry permit, and how current business practices fit within those uses;		
24	2. An analysis of whether changes are necessary to address employer work from		
25	home policies;		
26	3. An analysis of home occupation and home industry standards related to		
27	number of employees, customer and client visits, and traffic, and whether existing		
28	standards are appropriate under current conditions; and		
29	4. Any other issues identified by the executive as a result of the large number of		
30	people shifting to work from home permanently.		
31	C. The executive shall prepare a report summarizing the completed review		
32	described in this motion and any code changes necessary to implement the		
33	recommendations in the report. The executive should electronically file the report and		
34	any necessary code changes by October 31, 2022, to be considered as part of the 2024		

- 35 update to the King County Comprehensive Plan, with the clerk of the council, who shall
- retain an electronic copy and provide an electronic copy to all councilmembers.
