*On an emergency basis, the King County Council adopted Ordinance 19613 on May 16, 2023. The ordinance established a seven-month moratorium prohibiting subdivisions of residentially zone land in the Rural Town of Fall City; directing the executive to produce a work plan to address the issues and circumstances necessitating the moratorium. In accordance with state law, a public hearing is required to be held within sixty days of the adoption of the moratorium. The ordinance was advertised for a public hearing on May 26, 2023.*
