Ms. Patterson reported on the Sound Transit Capital Committee. The committee received an update on the north corridor transit alternatives. There are five alternatives that are being studied for the Northgate to Lynnwood alignment. Sound Transit is looking at the alternatives, and later on this spring the Board will select the final alternatives to move forward for an EIS. The committee was also briefed on the status of the North link project, which will run from the University of Washington to Northgate. The committee passed two motions regarding a study for the Sound Transit Express bus base and Sounder yard shop facilities projects. The committee also unanimously supported a new agreement with the city of Renton regarding the Rainier Avenue arterial improvement project and the Strander Boulevard extension project. This agreement will be sent to the Board for approval later this month or early February.

Mr. Phillips also made comments regarding Sound Transit and the north corridor.
