Ms. Patterson reported on her attendance at the National Association of Counties Western Interstate Region Conference. She indicated there was considerable

discussion on public lands, natural resources, forest protection, clean water, using public lands for recreational purposes, marine conservation and wildlife protection. The steering committee decided which policy resolutions would be forwarded with final vote taken in July. Once the resolutions are adopted, they are used to lobby Congress with. She also indicated that former Congressman Brian Baird, spoke about partisanship.

Mr. McDermott briefed the Council on the recent Board of Health meeting. The Board had a briefing on menu labeling, as included in federal law. The Board adopted a resolution to encourage county residents to join soda free Sundays, to not drink sodas or other sugary drinks at least one day each week for six seeks, a community wide effort to address childhood obesity.
