### 31. <u>Reports on Special and Outside Committees</u>

#### <u>play video</u>

Councilmember Patterson reported on the Sound Transit Capital Committee. The Committee received a briefing on the different alternatives being studied for the north corridor project, which will bring light rail from Northgate to Lynnwood. The Committee has done an analysis on bus rapid transit and light rail and the alternatives between using the I-5 and Highway 99 corridors. The Board will identify the final alternatives to be evaluated by the end of December. The Committee also received an update on the north link project which is a 4.3 mile light rail extension from the University District to Northgate. It is scheduled for completion in 2021. The briefing included an update on the three stations in the University District and the art and community outreach being planned for the project. The committee increased the total contract cost for the D to M Street project in Tacoma.

Councilmember Hague reported on the recent Eastside Transportation Partnership meeting. The members received a presentation from the Bus Rapid Transit Oriented Development study. The presentation highlighted the success of Rapid Ride A and the soon to be launched Rapid Ride B on the eastside. The members were also briefed on the congestion reduction charge from Victor Obeso, King County Metro. They discussed transit ridership increases and the impact of the CRC and its package to the eastside transit related community. The members received a presentation on the King County Electric Vehicle program and establishing a highway network for electric charged vehicles. The members also received a report on the Governor's Connecting Washington Taskforce and the PSRC project prioritization update.
