AN ORDINANCE related to how the county will honor civil immigration hold requests from the United States Immigration and Customs Enforcement for individuals in the custody of the department of adult and juvenile detention; adding a new section to K.C.C. chapter 2.15.

Clif Curry, Council staff, briefed the committee on the proposed ordinance. He reported on the contents of striking amendment S1 distributed at the meeting and on the changes between S1 and the striking amendment contained in the meeting packet.

Claudia Balducci, Director, Department of Adult and Juvenile Detention, answered questions of the committee.

Councilmember Gossett moved a do pass recommendation of the ordinance. Councilmember Gossett moved striking amendment S1.

Councilmember Lambert made an oral amendment on line 98 to delete "targeted" and insert "impacted." The amendment passed by a vote of 5 Ayes, 3 Noes (Dembowski, McDermott and Gossett) and 1 Excused (Dunn).

Councilmember Lambert made an oral amendment to delete lines 121-126. Councilmember Lambert withdrew the amendment

Councilmember Lambert moved to amend on lines 121 through 123, delete "B. ... result,". The motion failed.

Councilmember Dembowski moved amendment D-3. The motion passed unanimously.

Councilmember Dembowski moved amendment D-1. The amendment passed by a vote of 5 Ayes, 3 Noes (Patterson, McDermott and Gossett) and 1 Excused (Dunn).

Councilmember Dembowski moved amendment D-2. Mr. Dembowski clarified that this amendment D-2 amends the striking amendment as amended only from beginning on line 15 through line 22 "or where ... or". There was an oral amendment to insert on line 18 ",," after "(1), "," after "freedom", "," after "(3) and "," after "soldiers)". Mr. Dembowski accepted the amendment as friendly. The amendment passed by a vote of 5 Ayes, 3 Noes (Phillips, McDermott and Gossett) and 1

Excused (Dunn).

Councilmember Lambert moved amendment L-1. Mr. Curry clarified that this amendment amends the striking amendment at lines 11-12 "an offense ... 9.94A.411" and line 16 - 17 "or any ...9A.20.010; or". Councilmember Lambert withdrew the amendment.

Councilmember Lambert moved amendment L-2. Mr. Curry clarified that this amendment amends the striking amendment as amended to add the language "or has been charged with" to the list of crimes in amendment D-1. The motion failed.

Councilmember Lambert moved amendment L-3. Ms. Balducci answered questions of the committee. Wendy SooHoo, Council staff, answered questions of the committee. The motion failed.

Councilmember Lambert moved amendment L-4. Mr. Curry clarified the results of the amendment on the striking amendment. The motion failed.

Councilmember Lambert withdrew amendment L-5.

Councilmember Hague moved amendment H-1. Mr. Curry clarified that this amendment creates a new subsection E. to the striking amendment. Councilmember McDermott offered an oral amendment to insert on line 7 after "executive's designee," the director of the department of public defense, or the director's designee. Councilmember Hague accepted the amendment as friendly. The motion passed unanimously.

Voting on the striking amendment as amended, the motion passed by a vote of 6 Ayes, 1 No (Lambert) and 2 Excused (Dunn, von Reichbauer).

A motion was made by Councilmember Gossett that this Ordinance be Recommended Do Pass Substitute. The motion carried by the following vote:
