Councilmembers Kohl-Welles and Gossett reported on the Growth Management Policy Board meeting at which the 2016 King County Comprehensive Plan and the City of Seattle's 2006 updates were recommended for certification. The Board also recommended approving changes to the City of Lakewood's Comprehensive Plan. Councilmember Gossett reported that Pierce, King, Snohomish, and Kitsap Counties are making efforts to expand social equity in terms of the policies that are developed in the future and how to plan for development around military bases in the four counties.

Councilmember Lambert reported on the 75th Anniversary of the King County Libarary System and the E-911 Leadership Group meeting where funding priorities; technology and operations draft #1 recommendations; and governance were discussed.

Councilmember Upthegrove recognized the significance of today being September 11th, and acknowledged those who lost their lives.
