Patty Hayes, Director, Public Health - Seattle & King County, alerted the Board to an isolated case of Hepatitis A. Dr. Jeff Duchin, Public Health Officer, Department of Public Health, is monitoring this very closely.

Ms. Hayes also briefed the Board on the lawsuit filed against the Trump Administration for the defunding of the teen pregnancy prevention program. FLASH addresses topics important to preventing teen pregnancy that are not covered in other programs. It is also designed to meet the needs of all students, including youth in both rural and urban areas, youth of all racial and ethnic backgrounds, and young people of all sexual orientations.
