Chris O'Claire, Mobility Division Director, Metro Transit Department, commented on highlights of the American Public Transportation Association conference in New York. Per a request from the Council, Metro is looking at implementing an income based fare program in 2020. Metro's focus is to subsidized ORCA Lift cards for those who are at 80% of the federal poverty level or less. Metro hopes to launch paid solo driver permit parking by end of the year at nine park and ride lots that are above 90% occupancy. No more than 50% of stalls will be designated. Prices will vary depending on the location of the park and ride lot. About 10% of stalls will be set aside for ORCA Lift cardholders
