Call to Order

The meeting was called to order at 1:48 p.m.

Mr. Gossett moved to approve the minutes of the June 5, 2006 meeting as presented. Seeing no objection, the Chair so ordered.

2. Special Item

Presentation of a Recognition to the Seattle Prep Panthers for winning the 2006 Washington State 3A Boys Basketball Championship

Mr. Phillips invited Coach Mike Kelly and the team members to the podium as he made comments about the team's achievements. The team members in attendance were: Nate Girma, Jack Hanley, Victor Steinbrueck, Nicholas Fearn and Patrick Donnelly. Mr. Phillips read the recognition. Coach Kelly thanked the Council. Team member, Nicholas Fearn, recognized other team members who were not present, and also thanked the Council.

Mr. von Reichbauer added that Matt Gasparich, council staff, also was a Prep Panther.

3. Reports on Special and Outside Committees

Ms. Hague reported on the Puget Sound Regional Council Growth Management Policy Board meeting. The Board reviewed the Vision 2020 update, which is the four county vision for land use policies. The Board discussed planning policies and the evaluation criteria for selecting a preferred growth alternative.

Mr. Constantine also commented on the meeting.

Ms. Hague reported on the Eastside Transportation Partnership. The members had a presentation on SR 520 and its update and discussed the new legislative requirements for the Expert Review Panel. The members reviewed the release of the draft EIS and had a discussion and presentation on the

Sound Transit update and RTID update.

Ms. Hague reported on the recent meeting of the Puget Sound Regional Council Transportation Policy Board. The Board had briefings on the SR 520 bridge, the Alaska Way Viaduct project and a progress report on the implementation of the SR 167 hot lane project in South King County. The Board also unanimously recommended to the Executive Board that a major region wide study of passenger ferry service be funded by the PSRC. Ms. Patterson also commented on the upcoming visit to the San Francisco Bay area with the Discovery Institute to look at the Bay area's passenger ferry system firsthand.

Ms. Patterson reported on the Regional Transportation Investment District Executive Board. Mr. Dunn and Mr. Constantine were welcomed as new members. The Board reviewed its progress during the last six months to develop a draft plan, discussed the legislative session and major challenges ahead, such as revenue forecasts.

Ms. Patterson reported on the Sound Transit Board. The Board reviewed several packages of transit projects that will be combined with road projects and placed on the 2007 ballot. During the next few months, the Board will work on prioritizing transit investments.

Mr. von Reichbauer commented on his attendance at the Issaquah groundbreaking of the new park and ride lot.
