#### 1. Approval of Minutes of July 24, 2006

#### 3. Reports on Special and Outside Committees

Ms. Hague reported on the Regional Water Planning Coordinating Committee. The Committee heard the first report from the Tributaries Streamflow Subcommittee. The Subcommittee gave recommendations. Ms. Hague indicated all of the committees are inter-related with the end result being recommendations going forward to the Coordinating Committee. The Regional Water Planning Coordinating Committee will meet again in the next quarter to hear a report from another subcommittee.

Ms. Patterson reported on the Board of Health retreat. The Board discussed the operational master plan and the responsibilities of the Board of Health. The Board had a good brainstorming session on how the Board of Health can more effectively play a role in the budget process in King County. The Board initiated the formation of a subcommittee that will study the different operations, membership and desired roles of the members of the Board of Health.

Ms. Patterson reported on the Public Health Operational Master Plan Steering Committee. The Committee received its first draft of the policy framework. She indicated the policy framework paper will provide a long term framework for staff and legislators to help shape policy that is consistent with priorities and responsibilities of the Board of Health. Ms. Patterson indicated this important

public policy document on public health may be transmitted to the Council sometime in the fall.

Mr. Phillips reported on the Cedar River Council which is devoted to the health of the Cedar River. The Council discussed the status of the Cedar River Legacy Program. He made comments about the returning sockeye to the Lake Washington system. The members also had an update on the Elliott Bridge project.
