1. Call to Order

The meeting was called to order at 1:48 p.m.

The Chair recessed the meeting into Executive Session to discuss with legal counsel litigation or potential litigation to which the County is or is likely to become a party when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the County, at 2:22 p.m.

The Chair reconvened the meeting at 3:31 p.m.

Presentation of a Recognition Honoring 16 Year Old Megan Johnson for her Charitable Work in King County

Mr. von Reichbauer made comments regarding Megan's background, and spoke about her charitable work. He read and presented the recognition to Megan. Megan thanked the Council. Her mother also spoke.

6. Reports on Special and Outside Committees

Ms. Hague reported on the Eastside Transportation Partnership. The members discussed Sound Transit's Phase II, focusing on the sales tax increase draft project plan. The members also discussed the Burlington Northern Santa Fe Rail corridor and the options. A presentation was given on Transit Now regarding the Eastside Implementation Plan. The members heard a report on the state legislature session relating to tolling.

Mr. Phillips reported on the Sound Transit Board. The Board received a presentation regarding the public input process regarding Sound Transit II. Over 9,000 participants took part in a web based public involvement survey. A random telephone survey was also conducted. Mr. Phillips gave statistical information regarding the survey and indicated this was a good tool for the Board to gage

the urgency and action the citizens want Sound Transit to take.

Ms. Patterson briefed the Council on the March 12 emergency meeting of the Board Health. She thanked Councilmembers Ferguson, Lambert, Gossett and Dunn for their attendance. The Board passed amendments to the previously adopted menu labeling legislation. Consumers will continue to have easy access to nutritional information at the time that they order in restaurants. Ms. Patterson also indicated this groundbreaking is first in the nation.
