Mr. Phillips reported on the recent meeting of the Sound Transit Board and the milestone achieved for the entire region. The Board, by a vote of 16-2, approved a mass transit expansion plan known as ST2, which will go before the voters in November. Mr. Phillips explained the plan is a fifteen year plan that will increase bus and commuter rail service.

Mr. Constantine reported on the Sound Transit Operations Task Force. The members discussed upcoming needs and options for how to best provide maintenance and storage of Sounder commuter train service. Mr. Constantine explained it was the consensus of the committee that building and operating our own facility would present some interesting opportunities for Sound Transit and tax payers. Staff will be pursuing the options.

Mr. Phillips briefed the Council on the Cedar River Council, and its mission to protect the health of

the Cedar River. The Council met at the Lions Club facility on the banks of the Cedar River, and discussed a potential revised mission statement, as well as how to expand public education and outreach by the Council.
