5. Reports on Special and Outside Committees

Mr. Phillips briefed the members of the last Sound Transit meeting. The board received a year end report from the Diversity Oversight Committee. The oversight committee established policies and procedures to maximize diversity in Sound Transit contracts and the workforce. The committee noted an effort to insure the participation of local companies in the major contracting projects. The committee acknowledged some accomplishments but also noted in the area of outreach and request for proposals language may require further work. The committee is developing a tracking system to make sure that the diversity program is implemented. Mr. Phillips noted that Sound Transit also authorized owner controlled insurance programs for the University Link and a contract with the Capitol Hill Chamber of Commerce for business mitigation programs.

Mr. Phillips made a brief report of the last 4Culture meeting. The board authorized the funding of some projects. Mr. Phillips reported that the board received a presentation on the plans of the upcoming Alaska Yukon Pacific Exposition Centennial Celebration.

Mr. Phillips reported on the last Cedar River Council meeting. The board received a briefing on the sockeye hatchery and an update of the remarkable legacy program which is preserving habitat in the Cedar River.

Mr. Phillips reported on the Woodland Park Zoological Society meeting. Mr. Phillips noted that the society oversees the levies that support zoo expansion. He stated that the expenditures are being well spent.

Ms. Hague briefed the members of the Enterprise Seattle quarterly meeting. Ms. Hague reminded the members that Enterprise Seattle is a group made up of business, government and non profits to help promote civic economic vitality. The group received a briefing of the commercial real estate market and a directory of space for the King County region. The group meets again in November.
