Mr. Phillips reported on the Sound Transit Central Link Oversight Committee. The committee received an update and progress report on the initial segment. Construction is approximately 94 percent complete. Sixteen of 35 light rail vehicles have been tested and accepted. The committee will make a full report to the Sound Transit Board at the next meeting on November 20.

Ms. Patterson reported on the recent Board of Health meeting. The Board received a briefing from Public Health Director, Dr. Fleming. He provided an overview of Public Health's budget, which has impacts on many of our core government services. The Board of Health members will be speaking to the Council on Wednesday October 22nd, regarding cuts. The Board passed a resolution identifying twelve potential public health funding options which will be taken to Olympia for some help and also a resolution outlining strategies for improving children's nutrition. Ms. Lambert also made comments.

Ms. Patterson informed the Council that at a special Board of Health meeting on Friday, October 23, a briefing will be given outlining Senators Obama and McCain's healthcare plans.
