#### 6. Special Item

Presentation of a Proclamation declaring June 15, 2009, as Elder Abuse Awareness Day in King County

Mr. Phillips was joined at the podium by Councilmembers Patterson and Lambert.

Mr. Phillips spoke about Elder Abuse Awareness Day and specifically of two recent cases in the State of Washington. He introduced Claudia Donnelly, citizen advocate, and Lee Drechsel, Executive Director, Domestic Abuse Womens Network. Before reading the proclamation, Ms. Patterson and Ms. Lambert made remarks. Ms. Drechsel thanked the Council and introduced a new

advocate. Claudia Donnelly also made remarks.

### 7. Reports on Special and Outside Committees

#### Play Video

Ms. Patterson reported on the Puget Sound Regional Council Transportation Policy Board. The Board discussed the alternatives for Transportation 2040, this region's long range transportation plan. Ms. Patterson indicated that six plan alternatives are being considered, as well as the impacts on the environment. The Board is also considering how these investments can be sustained financially. Ms. Patterson will be reporting on the progress of Transportation 2040 throughout the remainder of PSRC Board meetings. PSRC's final vote on the plan will be in March, 2010.

Ms. Hague briefed the Council on the Eastside Transportation Partnership. The members discussed Metro service and budget. The members invited Metro staff to report back next month. ETP will plan to submit some written documentation to help guide them through budget and policy issues surrounding Metro.

Mr. Constantine reported on Sound Transit. The members approved land acquisitions in Tacoma. CEO, Joni Earl, reported on a new Sounder train that was added between Seattle and Tacoma beginning on June 1. Sound Transit has been working on new routings for buses in the Eastgate area. In anticipation of light rail's opening in July, the downtown Seattle transit tunnel is now open for extended hours.

Mr. Constantine reported on Sound Transit's Operations Task Force which includes regional leaders, focusing on operating the system. The Task Force plans to present to the Executive Director, a list of cost containment measures to operate more efficiently. This presentation will take place at the next Sound Transit meeting.
