Councilmember Ferguson moved amendment 1, which would assure greater transparency and accountability in implementation of the Veterans and Human Services Levy Plan by adding service procurement and annual reporting requirements, clarifying and further specifying the role and responsibilities of two required oversight boards regarding these requirements and acknowledging the ultimate fiduciary roles and responsibilities of the King County Council. Councilmember Putter moved a friendly amendment to insert on line 15 of the amendment after "Council" the words "and the Regional Policy Committee". The amendment passed unanimously.
