Small Business Development and Apprenticeship Programs

The booklet entitled, "Business Connections" was distributed to the councilmembers.

Willie Winston, King County citizen, commented on suggestions to improve the King County programs. A copy of his comments was distributed to the members. Elaine Ko, Director, Office of Social Responsibility, Port of Seattle, discussed the Port of Seattle's program goals and achievements and answered questions from the members. A MOTION approving a plan for regional voting centers and ballot drop boxes as required by Ordinance 15523 and giving approval for the executive to enter into an interlocal agreement to implement the plan.

Mike Alvine, Council Staff, briefed the committee and answered questions from the members. Cheryl Huff, Director, Elections Division, Alex Herzog, Analyst, Vote-by-mail Project, Elections Division, and Bill Huennekins, Manager, Vote-by-mail Project, Elections Division, answered questions from the members. Councilmember Patterson moved Amendment 1 which clarifies that the Renton RVC will be open for 20 days and that the Seattle and Bellevue RVC's will be open for four days. Amendment 1 passed 7-1, with Councilmember Lambert voting no and Councilmember von Reichbauer excused. Councilmember Patterson moved Amendment 2 which replaces an out of date list of ballot drop box locations with an updated list. Amendment 2 passed unanimously. Councilmember Patterson moved Amendment 4 which directs the Elections Director to work with advocacy groups and Metro transit to ensure that adequate transportation is available to the regional voting centers for voters with disabilities. The amendment passed unanimously. Councilmember Patterson moved a title amendment. The title amendment passed unanimously.
