These grants are targeted to tobacco prevention and healthy eating and active living.

Ms. Hague reported on the Growth Management Planning Council. The work plan for the year was outlined and the Council will spend most of the year bringing the Growth Management Planning Council amendments into compliance with the Puget Sound Regional Council's 2040 plan.
