BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. Ordinance 13332, Section 38 as amended and K.C.C. 27.10.230 are each hereby amended to read as follows:

A fixed Fee for the processing of current use permits shall be charged as follows:

A. Farm and agricultural land classification

\$181.00

B. Open Space and timber <u>land</u> ((less than twenty acres))

\$((241.00))

<u>480.00</u>

((Open space and timber greater than twenty acres

\$483.00))

SECTION 2. Ordinance 13332, Section 38, as amended, and K.C.C. 27.10.230 are each hereby recodified as a new section in K.C.C. chapter 20.36.
