STATEMENT OF FACTS

1. Increasing numbers of unemployed workers in King County require assistance in order to be

re-employable.

2. The King County dislocated worker program is prepared to provide that assistance using

federal funds allocated to the program by the

Workforce Development Council and the governor of the state of Washington.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 14265, Section 88, as amended, is hereby amended by adding thereto and

inserting therein the following:
