WHEREAS, Ordinance 17696, contained a proviso in Section 19, which amended the 2013/2014

Biennial Budget Ordinance, Section 109, as amended, stating that five million dollars could not be encumbered or expended until the executive transmitted a solid waste interlocal agreement review report and a motion that acknowledged receipt of the report and the motion was passed by the council, and

WHEREAS, the solid waste division, with participation of the metropolitan solid waste advisory committee and the financial policies subcommittee, reviewed issues identified in Ordinance 17677, and

WHEREAS, based on that review, the division developed a report addressing the requirements of
