BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 19210, Section 112, as amended, is hereby amended to read as follows:

Wastewater treatment \$1,435,000

The maximum number of additional FTEs for wastewater treatment shall be: 12.0

SECTION 2. Ordinance 19210, Section 129, as amended, is hereby amended to read as follows:

From the water quality construction fund there are hereby appropriated and authorized to be disbursed

the following amounts for the specific projects identified in Attachment A to this ordinance (Proposed Ordinance 2021-XXXX).
