BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and two memoranda of agreement (Addressing The 2011 Budget Crisis and Footwear Allowance) negotiated by and between King County and Joint Crafts Council representing employees in the departments of adult and juvenile detention, executive services, natural resources and parks, public health, and transportation and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the collective bargaining agreement and memorandum of agreement regarding Footwear Allowance shall be effective from February 1, 2010, through and including January 31, 2014. Terms and conditions of the memorandum of agreement regarding Addressing The 2011 Budget Crisis shall be effective from January 1, 2011, through and including December 31, 2014.
