AN ORDINANCE adopting the revision of voting precincts of King County for the year 2006.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to K.C.C. 1.12.010.E. and RCW 29A.16.040, the 2006 revisions and alterations to the King County voting precincts as contained in the attachments to this ordinance are adopted and shall constitute an amendment to the

official list of county voting precincts maintained by the records, elections and licensing services division.
