AN ORDINANCE approving and adopting a collective bargaining agreement, memorandum of agreement and memorandum of understanding negotiated by and between King County and International Brotherhood of Teamsters Local 117 (Legislative Analysts) representing employees in the King County council; and

establishing the effective dates of the agreements.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement, memorandum of agreement and memorandum of understanding negotiated by and between King County and International Brotherhood of Teamsters Local 117 (Legislative Analysts) representing employees in the King County council and attached hereto are hereby approved and adopted and by this reference made a part hereof.

SECTION 2. Terms and conditions of the collective bargaining agreement and the memorandum of understanding shall be effective from September 11, 2009, through

June 30, 2013. Terms and conditions of the memorandum of agreement shall be effective from January 1, 2011, through December 31, 2014.
