SECTION 1. The memorandum of understanding extending for twelve months the terms and conditions of the collective bargaining agreement negotiated between King County and Service Employees International Union, Local 925, representing employees in the department of executive services (facilities management) and department of natural resources and parks (parks and recreation) and attached hereto is hereby approved and adopted by this reference made a part hereof.
