## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement negotiated by and between King County and the Joint Labor Management Insurance Committee regarding insured benefits for represented benefits-eligible employees (except those represented by the Amalgamated Transit Union, Local 587 and the King County Police Officers Guild) and attached hereto is hereby approved and adopted by this reference made a part hereof.

<u>SECTION 2</u>. Terms and conditions of said agreement shall be effective from January 1, 2014, through and including December 31, 2016.
