AN ORDINANCE relating to the annexation of an area of land known as annexation area 2003-2 into the Val Vue Sewer District for the purpose of providing sewer service for future development.

### STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of an area known as annexation area 2003-2 into the Val Vue Sewer District for the purpose of providing sewer service for future development was filed with the county council on October 25, 2004.
2. Val Vue Sewer District has found the petition for transfer to be sufficient and has concurred with the proposed transfer in Resolution No. 2004-8, passed on September 7, 2004.
3. Val Vue Sewer District filed a Determination of Nonsignificance on the proposed annexation

dated August 25, 2004.

4. The utilities technical review committee recommended county council approval of the proposed annexation.

5. The county council held the legally required public hearing and has considered the criteria in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of an area known as annexation area 2003-2 into Val Vue Sewer District for the purpose of providing sewer service for future development described in Attachment A of this ordinance is approved. Approval of this proposed annexation is consistent with RCW 57.02.040.

SECTION 2. Val Vue Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.
