AN ORDINANCE authorizing the executive to execute an interlocal agreement with the city of Seattle to regulate for-hire transportation.

### STATEMENT OF FACTS:

1. Due to changes in state law governing the regulation of transportation network companies, modifying K.C.C. chapter 6.64 that regulates transportation network companies and establishing a new King County Code chapter to regulate taxicabs and for-hire vehicles best articulates the

county's objectives for that industry.

2. The county partners with the city of Seattle through an interlocal agreement to regulate the for-hire transportation industry and desires to maintain that partnership under common regulations in the future.

3. The county and the city of Seattle last updated the interlocal agreement concerning for-hire transportation in August 1995.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The executive, or designee, is authorized to execute the Interlocal

Agreement for For-Hire Transportation with the city of Seattle, which is Attachment A to this ordinance.
