## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated between King County and Teamsters

Local 117 (Professional & Technical Employees) representing employees in the departments of adult and juvenile detention, executive services, natural resources and parks, public health, and transportation and attached hereto is hereby approved and adopted by this reference made a part hereof.
