## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental request of \$1,225,095 to the

automated fingerprint identification system fund and \$14,311,058 to the building capital improvement fund.

SECTION 2. Ordinance 14265, Section 75, as amended, is hereby amended by adding thereto and inserting therein the following:

SECTION 3. Ordinance 14265, Section 119, as amended, is hereby amended by adding thereto and inserting the following:

From several capital improvement project funds there is hereby appropriated and authorized to be disbursed the following:

## PROVIDED FURTHER THAT

For Project 395716, titled Courthouse South Addition, the appropriated amount includes funding for consulting services for independent project monitoring. The scope of work for the independent project monitoring will include at a minimum:

1. Project monitoring of compliance with generally accepted project management practices. Intent of such review is to provide reasonable assurance to the County that financial responsibilities and compliance with generally accepted project management practices are achieved throughout the project.

2. Monitoring of compliance with adopted scope, schedule and budget during construction phases.

3. Monitoring during all phases to assess the adequacy and accuracy of management reports.

4. Confirmation of the construction progress and evaluation of the contractor's monthly payment

requests.

5. Review of any proposed change orders for suitability of the change work scope.

6. Comments on schedule compliance and work rate including opinion of ability to meet the completion date.

Deliverables for these consulting services will include: a. monthly written reports reviewing the current construction progress, workmanship quality and assessment of overall project management including review of the Seneca Real Estate Group's monthly report and the county's move plan concurrently submitted to the executive and the council in coordination with the courthouse seismic project monthly report; b. monthly meeting with executive staff; and c. quarterly presentations to the budget and fiscal management committee.
