AN ORDINANCE relating to King County district court electoral district

boundaries for 2013; and amending Ordinance 17312, Section 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 17312, Section 1, as amended, is hereby amended to read as follows:

A. The district court west electoral district shall be all of the area within the line described in subsection

B. of this section. The boundaries of the other district court electoral districts shall consist of the election

precincts in subsection C. of this section. The precincts listed in this section consist of election precincts that

have been established by the King County council under K.C.C. 1.12.010.

B. West electoral district: all of the area within the boundary of the city of Seattle which includes to the

centerline of the waters of Puget Sound and the centerline of Lake Washington.

C. The boundaries of the other electoral districts shall consist of the election precincts in Attachments A through D of this ((2012)) <u>2013</u> ordinance (Proposed Ordinance ((2012-0138))) <u>2013-0179</u>), as listed in this subsection, which shall be retained officially on file in the department of elections, with copies maintained by the clerk of the council and the presiding judge of district court.
