AN ORDINANCE establishing a fee for radius batch searches conducted by the

department of assessments; and adding a new chapter to K.C.C. Title 4.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. A. Sections 2 through 5 of this ordinance propose imposing a fee for conducting radius batch searches in accordance with K.C.C. Title 21A by the department of assessments.

B. These fees are imposed under K.C.C. 2.99.030.

SECTION 2. Sections 3 through 5 of this ordinance should constitute a new chapter in K.C.C. Title 4.

NEW SECTION. SECTION 3. Authorization to assess fee. The King County department of

assessments may assess a fee for conducting radius batch searches in accordance with K.C.C. Title 21A, to cover administrative and duplicating costs.

<u>NEW SECTION. SECTION 4.</u> **Fee.** The radius batch search fee shall be fourteen dollars and seventy-five cents per search.

<u>NEW SECTION.</u> SECTION 5. **Procedure for collection.** The department of assessments shall establish by rule a procedure for collection of the fee.
