STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of approximately 301.6 acres of land into the King County Water District No. 119, known as the Stuart Annexation, for the purpose of providing water service was filed with the county council on June 6, 2005.

2. King County Water District No. 119 has found the petition for transfer to be sufficient and

has concurred with the proposed transfer in Resolution No. 427, passed on April 6, 2005.

3. King County Water District No. 119 adopted a Determination of Nonsignificance on the

proposed annexation in Resolution 426 passed on April 6, 2005.

4. The utilities technical review committee recommended county council approval of the

proposed annexation.

5. The county council held the legally required public hearing and has considered the criteria in

RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of approximately 301.6 acres of land into King County Water District No.

119 for the purpose of providing water service described in Attachment A of this ordinance is approved.

Approval of this proposed annexation is consistent with RCW 57.02.040.

SECTION 2. King County Water District No. 119 is the appropriate entity to serve the area proposed to

be annexed.

SECTION 3. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service to this annexation

area.
