WHEREAS, the duly appointed manager of treasury operations of King County, Washington has made

an affidavit pursuant to the terms of RCW 84.56.240 and 84.56.260 to the King County council relating his

diligent search and inquiry for goods and chattels of the persons appearing on the list of delinquent taxpayers

and his inability to find any such property from which said taxes could be collected, and

WHEREAS, the duly appointed manager of treasury operations of King County, Washington has

requested the authority from the King County council to cancel said taxes;

NOW, THEREFORE, BE IT MOVED by the King County Council:
